**Background**

The Elk Grove Alumnae Chapter of Delta Sigma Theta Sorority, Incorporated (largest predominantly African American Sorority), proudly announces the 2026 Theresa A. Pradia HBCU Book Scholarship Application for deserving high school students from Sacramento or Yolo Counties that have been admitted (or currently attending) an accredited Historically Black College or University for the 2026-2027 Academic Year. This scholarship fund was created in memory of Theresa A. Pradia who was a proud HBCU Alumni of Southern University, where she was initiated at Alpha Tau Chapter, and a long-standing member of Delta Sigma Theta Sorority, Incorporated for over 60 years!

**Available Scholarships for 2026 - 2027** • \$500 HBCU Book Scholarship (multiple scholarships to be awarded).

**Scholarship Eligibility**

- Current graduating African American (male or female) high school senior as of Spring 2026, at any high school in Sacramento or Yolo County are eligible to apply; OR a current matriculated student at an HBCU that attended high school in Sacramento or Yolo County.
- Must be a full-time undergraduate student at an accredited Historically Black College or University (HBCU) by the Fall of 2026.
- Applicants must have a minimum GPA of 2.5 (4.0 scale) and demonstrate financial need.
- Applicants should demonstrate their motivation to attend an accredited HBCU and potential for continued matriculation.
- Selected recipients will receive their scholarship directly after enrollment verification is received from HBCU Registrar's Office with proof of Fall Enrollment.

Students Are Eligible to Apply if they are currently enrolled in any high schools in any School District within Sacramento or Yolo Counties.

- Unofficial high school transcript (mailed or sent from school via email). Students selected for scholarship will need to provide a final completed official high school Transcript. Official HBCU Transcripts for matriculated college students.
- Documentation of financial need as determined by their submitted FAFSA.
- In lieu of an in-person interview, you must submit a video recording that answers the appropriate question below. Video recording should be 5 minutes or less using a streaming platform (i.e. YouTube unlisted link, Zoom recording, Vimeo, etc.).

#### **Scholarship Background:**

Delta Sigma Theta Sorority, Inc. is the largest predominantly African-American Sorority in the world and is committed to scholarship, sisterhood, and service. Elk Grove Alumnae Chapter was chartered on December 11, 2004 and Mrs. Jacquelyn M. Ward became the first chartering president of the chapter that would serve Elk Grove, South Sacramento, Natomas, and West Sacramento. President Ward was not only a strong visionary, but her background to serve others came from her career as an RN and nurse practitioner alongside her husband. Mr. Ward was a nurse manager for the Department of Veteran Affairs at Mather AFB, and held many managerial roles in health care over the length of his career including Kaiser Permanente and Sutter Health Foundation. They both served their communities with strong conviction, at a time when there were very few African American nurse practitioners and male RNs.

#### **Available Scholarship:**

**Δ \$1,500.00 Nursing student scholarship (Selected applicant is eligible for additional years of funding)**

#### **Scholarship Criteria:**

- Students must be enrolled at a Community College or 4 year Institution who have been accepted into a Nursing Program.
- Students must identify as Black/African American male or female.
- One applicant will be selected with preference given to newly admitted nursing students.
- Documentation of financial need as determined by their submitted FAFSA.
- No Minimum GPA requirement, however, must submit official transcripts and be accepted into an accredited Nursing Program.
- Applicants must have been a resident of the Sacramento Region while in high school. Sacramento students who are admitted into a nursing program outside the region or state also qualify.

#### **Application Guidelines (Read completely before filling out application)**

Application deadline is April 30, 2026 and must be received by The Elk Grove Alumnae Chapter Scholarship Committee. Late applications will NOT be accepted.

- In lieu of an in-person interview, you must submit a video recording that answers the appropriate question below. Video recording should be 5 minutes or less using a streaming platform (i.e. Youtube unlisted link, Zoom recording, Vimeo, etc.)

#### **Applicant Video Recording Question(s):**

- Why is representation of black professionals important in the nursing field?

- Δ A Spring 2026 graduating high school African American female senior who resides in West Sacramento, CA
- Δ A scholarship will be granted to a successful candidate who can demonstrate outstanding performance in his/her academic, community service and leadership achievements.

Application must be received by The Elk Grove Alumnae Chapter by April 30, 2026 .

**Late applications will NOT be accepted.**

- Δ Applicants must be a graduating senior with a record of community service in non-school sponsored activities and participation in extracurricular school activities.
- Δ Applicants must have a minimum GPA of 2.5 (on a 4.0 scale) higher and plan to attend an accredited four-year university.
- Δ Applicants must have a typed application, with a letter of recommendation from a school teacher or counselor with their application, and unofficial transcript attesting that they are an eligible candidate for this scholarship (home address on file is in West Sacramento).
- Δ You must submit a video recording that answers one of the questions below. Video recording should be 5 minutes or less using a streaming platform (i.e. Youtube unlisted link, Zoom recording, Vimeo, etc.)
